**Commercial Building Inspector**

Mayor Steele presented to Council the issue of Commercial Building Inspector. If the Council chooses to select the State Building Inspector, the City will get \$50.00 per building permit and the balance will go to the state. If the City chooses its own Commercial Building Inspector, the City will receive 1/2 of the building permit fee.

Joe Parsons submitted the following proposal:

\$400.00 per month (includes 10 visits)  
\$40.00 each additional visit  
1/2 of the building permit fees  
1/2 of the zoning review fees  
City to pay his liability coverage

Mayor Steele met with Mr. Parsons, stating that either party could sever ties at any time.

Councilman Suttles made the motion to accept Mr. Parsons offer, instructing the Mayor to enter into a written agreement with the termination clause as the Mayor explained and documenting Mr. Parsons' activities with Barry Robinson Jr. Seconded by Councilman Stamper. Councilman Suttles made the modification to the motion that the Mayor will enter into a verbal agreement with Mr. Parsons. Councilman Stamper seconded the motion as modified.

**Business License Fee Amendment**



Motion to enter into executive session made by Councilperson Crum. Seconded by Councilman Stamper. Motion carried.


No action taken in executive session.
